A Message from the Executive Director

The top story in fiscal year 2017 was the opiate epidemic. Our media partners, on an almost daily basis, highlighted a story about the opiate epidemic devastating our valley. At first, the most frequently asked question was "why"? Why Trumbull County? Why my child? Why is this happening? After the "why's", "what" was a close second. What can we do? What will make an impact? What will slow down this horrible epidemic? Finally, "when" became a constant question. When are the deaths going to end? When will our first responders get a break? When will all of the strategies being implemented make a difference?

State and local data from 2016 indicate that laws to reduce doctor prescribing did make an impact. Deaths from prescription drugs continued to decline. However, deaths from synthetic fentanyl, in its many forms, have skyrocketed. That's what many don't understand about the disease of addiction. You can reduce the supply of pills, but the addiction has already taken hold. The move to heroin, and fentanyl, is swift and easy. The drugs are available in every community and the cost to produce them is at an all-time low. That makes the supply and demand a deadly combination.

In order to stop this epidemic, we have to stop new users from ever starting. The Board continues to invest in prevention programs in the schools, in education and marketing that addiction is a disease, and in treatment and recovery. We also continue to build partnerships with law enforcement, the medical community, faith-based groups and so many others. We do all that we can to support one another, to provide hope and resources to get through another day.

I don't know anyone who hasn't been touched by this epidemic in some way. For those of you who have stepped up, showed up and reached out to make a difference, thank you. Thank you on behalf of the children who have lost a parent; or parents who have buried a child. Thank you on behalf of the person living in recovery because they received the medical care and the help that they needed. And, for those who have made it to recovery, thank you for giving back to another in need. Isn't that why we are all here anyway?

TCMHRB Marks Its 200th CIT Graduate

Crisis Intervention Team (CIT) training programs are local initiatives designed to improve the way law enforcement responds to people experiencing behavioral health crises. They are built on strong partnerships between law enforcement, mental health and addiction provider agencies, and individuals and families affected by mental illness and addiction. Trumbull County's fourteenth training was held in October, 2016. Twenty—one officers completed the five—day training, including eight from Warren City; four from the Trumbull County Sheriff's Office; two each from Howland, Hubbard, and Liberty Townships; and one each from Hubbard City, Girard City, and Brookfield Township, along with a dispatcher from the Trumbull 911 Center. A total of 201 police and corrections officers from 28 jurisdictions have completed the training since the program began in 2006. This total includes 55 officers from Warren City, 30 from the Sheriff's Office, 19 from Howland, 15 from Hubbard Township, 12 from Liberty, and 10 from Hubbard City. All trainings rely on professionals from our provider network who donate their time and expertise, and on consumers and family members who share their experiences with members of the class. Mental Health First Aid

Mental Health First Aid (MHFA) teaches how to identify and respond to the warning signs of mental illness and substance use disorders and how to link people with appropriate treatment and support. Just like CPR, Mental Health First Aid participants are taught a five-step action plan to prepare them for interacting with someone experiencing a mental health problem or crisis.

Since 2013, 13 trainings have occurred, certifying 230 people. This year, the Tribune Chronicle recognized the program with an "Orchid Award." One participant surveyed wrote, "I now feel more sensitive to those who have mental health issues and feel better prepared to jump in and get help for those who ask for it, or those who may not know who to contact for help."

Highlights

ASAP: The Alliance for Substance Abuse Prevention Opiate Task Force

The Trumbull County Mental Health and Recovery Board continued to serve as the administrative agent for ASAP (the Alliance for Substance Abuse Prevention) in FY 2017. The Board provides support to ASAP by funding the project director and coalition coordinator positions as well as numerous projects and events. All Board staff play a role in the organizational management of ASAP and they and Board members are very active at all ASAP events.

Four Trumbull County events occurred, thanks to a grant from the Mercy Health Outreach Program. At the ASAP Summer Track Meet 189 youth, from 27 school districts, received drug prevention education and participated in the event. McDonald and Warren track teams played key roles in making the day a success! ASAP coordinated its 4th Annual Recovery Rally and Walk in September of 2016. Nearly 500 walkers and 100 volunteers attended to celebrate recovery in our Community. The Recovery Rally and Walk aims to stop the generational cycle of addiction by providing hope and proving that treatment works and people do recover.

Two community education events also occurred - the 4th Annual Hope for Recovery and 3rd Annual ASAP Drug Summit. Hope for Recovery was attended by over 300 family members and friends of a person with an addiction. Attendees learned about the science of addiction, the importance of self-care and heard stories from those in recovery. Thirty-four agencies provided resources to participants. Finally, 194 addiction professionals received training on modern evidence-based practices to employ when treating the disease of addiction.

ASAP provides resources to schools, community and faith based groups. Membership in ASAP is open to anyone interested in reducing drug abuse and promoting recovery in Trumbull County. Call 330-675-2765 ext. 119 for more information.

Highlights

School Based Prevention Services

Prevention is a major priority of the Trumbull County Mental Health and Recovery Board. Investing in evidence-based programming can prevent or reduce future substance abuse issues and mental illness. In Fiscal Year 2017, the Board expanded prevention efforts and funded services in 19 out of 21 Trumbull County school districts, our most comprehensive coverage to date. The Board continued their new model for Alcohol, Tobacco and other Drug Prevention, in which a Certified Prevention Specialist is embedded within the school district, providing a minimum of 4 hours of service per week. Prevention specialists from three contract agencies implemented evidence-based curriculum (i.e. Too Good for Drugs, Project Alert and LifeSkills) in the classrooms, organized and supported youth-led groups (PANDA Leaders Club, Mahoning Valley Teen Institute and Our Voices Matter), and provided professional training and consultation. TCMHRB also continued the expansion of resiliency-based mental health prevention, centered on the Search Institute's Developmental Assets framework. 




Golf Outing



Congratulations to the Rich O'Donnell Landscaping team who came in first place, shooting a 16 under par, tying the tourney record.








