

CIT TRAINING IN TRUMBULL COUNTY



Trumbull County's first CIT training was held in February 2006 and was attended by eight officers from three jurisdictions (Howland, Liberty, and Warren City). Our fifteenth training session was held in October 2017 and was attended by 19 officers from six jurisdictions. This brought the total number of officers trained to 221 and jurisdictions represented to 28.
