

CIT TRAINING IN TRUMBULL COUNTY



Trumbull County's first CIT training was held in February 2006 and was attended by eight officers from three jurisdictions (Howland Township, Liberty Township, and Warren City). Our twentieth training session was held in November 2023 and was attended by 15 officers from eight jurisdictions. This brought the total number of officers trained to 324 and

jurisdictions represented to 33. Departments with the largest number of trained officers are Warren City, Trumbull County Sheriff's Office, Howland Township, Niles City, Hubbard Township, Liberty Township, and Hubbard City.
