Preliminary

- 1. President Virginia Cluse called the meeting to order at 4:30 PM.
- 2. Pledge of Allegiance.
- 3. Secretary Louise Kline called the roll of members and certified that a quorum was present.
- 4. David Spies made a motion, seconded by Kevin Stringer, to approve the January 17, 2023 Board meeting minutes. The motion passed unanimously.

Report from the Executive Director

- 1. State Update ED Caraway provided an update on the Biennial Budget. Many of the funding recommendations for FY24 are reduced in FY25 so we will continue to follow the budget process and advocate as appropriate for continued funding. ED Caraway shared that Governor DeWine is recommending more funding to increase Adult Care Facilities across the state. She said two Trumbull County mental health group homes closed in the past couple of years. Anyone interested in operating a group home should contact John Myers. Next, ED Caraway spoke of the 120-day notices that will be voted on under "New Business." Funding changes are not anticipated, but ORC 340 requires ADAMHS Boards to send out these notices.
- 2. Local Update ED Caraway called attention to the revised agenda containing new motions as recommended by Treasurer Grahn and the Budget and Finance Committee. ED Caraway shared that a new capital grant request will be submitted to OhioMHAS for the Crisis Center and Supportive Housing project. The next step will be to post bids for an architect. ED Caraway said she has been trying to obtain ARPA and/or CDBG funding to help with the project.
- 3. Finance Report Patricia Shepherd, CPA, reviewed the January 2023 unaudited Revenue and Expenditure Reports. Shepherd noted that last month we started the FY21 OhioMHAS audit, also known as the Stakeholder's Assistance Review (SAR). Positive feedback has been received thus far. Shepherd then notified the Board that the Trumbull County Auditor's office has initiated the countywide audit and we are currently providing them the requested documentation on grants, inventory and variance details for calendar year 2022.
