

Board Meeting Minutes August 18, 2020 4:30 PM via Zoom

Preliminary

- 1. President Tom Harwood called the meeting to order at 4:33 PM
- 2. Attorney Brendan Keating administered the oaths of office for reappointed Board member, Cindy Klein, and the officer's oath of office for President Tom Harwood
- 3. Secretary Debbie Tominey called the roll of members and certified that a quorum was present
- 4. Vince Peterson made a motion, seconded by Carl Clark, to approve the July 21, 2020 Board meeting minutes. The motion passed unanimously.

Report from the Executive Director

- 1. State Update ED Caraway and John Myers provided an overview of the FY21-FY22 Community Plan that was reviewed in greater detail at the August Program Committee meeting. President Harwood and ED Caraway will sign the approved plan tomorrow so that it can be uploaded to OhioMHAS.
- 2. Local Update ED Caraway provided a review of the contracting process and summary contained in the Board packet. She indicated that because of Trumbull County's high overdose rate (currently 7th out of 88 counties), high Medicaid eligibility rate and the fact that Trumbull and Lake Counties are on deck for the statewide opiate lawsuit, substance abuse treatment agencies from all over the state are opening up satellite offices in Trumbull County. Because there is a finite amount of money available and more service providers than are needed, the Board cannot contract with every agency that moves into the community. She then referred members to the overdose data contained in the Board packet. ED Caraway then summarized the ongoing project to house the homeless and the great services being provided by the two Coleman navigators who are assisting with their daily needs and helping them complete applications, get birth certificates, and overcome barriers so that they can move in to long term housing. Grants received to help with the homeless project The Youngstown Foundation \$10,000, The Community Foundation \$5,000, the Trumbull Memorial Hospital Foundation \$10,000.
- 3. Finance Report Patricia Shepherd, CPA, reviewed the July 2020 Revenue and Expenditure Reports. She highlighted two items at 100%, under Other Contract Services, which are payments that are issued annually at the beginning of the new fiscal year the Family Dependency Treatment Court and the Family and Children First Council. In response to guidance from the federal Auditors

last year, we are reporting HUD funds on separate lines in QuickBooks. These are "passthrough" grants to Coleman for Joey's Landing and Shelter Plus Care/HUD and funding is designated to provide permanent supportive housing to people with behavioral health needs.

- 1. Addictions and Mental Health Program Committee Chairperson Jeff Goodman highlighted the community plan and early childhood mental health program presentation.
- 2. Administrative Committee Chairperson Virginia Cluse indicated there was no meeting.
