

CIT TRAINING IN TRUMBULL COUNTY



Trumbull County's first CIT training was held in February 2006 and was attended by eight officers from three jurisdictions (Howland Township, Liberty Township, and Warren City). Our eighteenth training session was held in July 2021 and was attended by 24 officers from eleven jurisdictions. This brought the total number of officers trained to 288 and

jurisdictions represented to 32. Departments with the largest number of trained officers are Warren City, Trumbull County Sheriff's Office, Howland Township, Hubbard Township, Niles City, Liberty Township, and Hubbard City.
